

Modern Slavery Policy for Medi-Plinth Equipment Limited

1. Introduction

Medi-Plinth Equipment Limited is committed to conducting business in a responsible and ethical manner. We fully recognize the importance of preventing modern slavery and human trafficking in our operations and supply chains. This policy sets out our commitment to tackling modern slavery and human trafficking and outlines the steps we are taking to ensure compliance with the Modern Slavery Act 2015.

2. Purpose

The purpose of this policy is to ensure that Medi-Plinth Equipment Limited maintains zero tolerance towards modern slavery, human trafficking, forced labour, and any form of exploitation within our business operations and supply chain. We are dedicated to ensuring transparency and fairness in all business practices and expect the same high standards from all our suppliers, contractors, and partners.

3. Scope

This policy applies to all employees, directors, contractors, consultants, suppliers, and any other third-party entities acting on behalf of Medi-Plinth Equipment Limited. It covers all business operations, including procurement, production, logistics, and all partnerships.

4. Commitment to Ethical Practices

Medi-Plinth Equipment Limited is committed to:

6. Supply Chain Standards

- Comply with all relevant laws and regulations, including the Modern Slavery Act 2015.

7. Due Diligence Process

11. Compliance and Accountability


